If at any time a component part is defective, TYTAX FACTORY S.C. shall repair or replace it (at TYTAX FACTORY S.C.'s option) within a reasonable period of time.

This warranty does not cover costs of removal, transportation or re-installation. This warranty shall not apply if the defect was caused by misuse, neglect or normal wear and tear of the product purchased. All claims require: Machine model name, Customer code number, Date of installation, and any information supporting the existence of the alleged defect.
